

Terms and Conditions

The UK REGO Day 2024 is hosted by RECS Energy Certificate Association (RECS) in collaboration with ACT Group and SmartestEnergy. The UK REGO Day will be held on Thursday, 5 December 2024 from 10.00-17.00 at the Hilton London Canary Wharf Hotel.

After the UK REGO day, registered delegates are invited to join RECS, ACT Commodities, and SmartestEnergy for drinks from 17:00-18:00.

Registration

The registration fee for RECS members is £100 ex VAT, for non-RECS members the fee is £200 ex VAT.

The registration fee includes:

- Access to all sessions during the event
- A copy of the meeting program
- Online access to meeting papers (after the event)
- Refreshments and lunch
- Attendance at the post-event drinks (17:00-18:00).

Payment

Payment for tickets to the UK REGO Day 2024 can only be made via credit card. After registering for the UK REGO Day, you will receive a confirmation email of your registration that includes an invoice in PDF format (within 24 hours). If the payment has not been received before the start of the conference, delegates will be asked to provide payment on-site via credit card. RECS reserves the right to refuse entry. Before traveling to the conference, we recommend you check with your finance department to ensure that payment has been settled.

Cancelation Policy

Cancellations made within 48 hours (about 2 days) of receipt of registration will be eligible for a full refund. Cancellations received in writing more than two weeks prior to the start of the event will be refunded minus a

50% cancellation fee. Cancellations received in writing less than two weeks before the starting date of the event will not receive a refund and you will be liable for 100% of the invoiced amount. However, a substitute delegate can be named at any time before the event starts, or a conference voucher (with the same value; valid for one year) will be offered.

If the event cannot be held due to circumstances created by a global pandemic, the event will be postponed. Tickets paid for in full will remain valid on the new conference date.

Important Notes

The UK REGO Day ticket registration/booking form constitutes a legally binding contract. It may be necessary for reasons beyond the control of the RECS to change the content and timing of the program, the speakers, the date, or the venue for the conference. RECS retains the right to cancel the event without providing restitution.

Please also be advised that filming/photography may occur during the UK REGO Day 2024. When you attend this event, you may enter an area where photography, audio, and video recording may occur.
