



# Terms and Conditions

The Open Markets Committee (OMC) is hosted by RECS Energy Certificate Association (RECS) and the Association of Issuing Bodies. The OMC will be held on Wednesday, 21 May 2025 at the Umweltbundesamt (UBA).

After the OMC has concluded, registered delegates are invited to join RECS and the AIB for drinks and dinner. The exact location and time for these social events are to be determined, and RECS reserves the right to change the time of these networking events as necessary.

## Registration

The registration fee for RECS members is €150 ex VAT and for non-RECS members the fee is €300 ex VAT.

The registration fee includes:

- Access to all sessions during the event
- An online copy of the meeting program
- Online access to meeting papers (after the event)
- Refreshments and lunch
- Attendance at the post-event drinks.
- Attendance at the post-event dinner.

## Payment

Payment for tickets to the OMC can only be made via credit card. After registering for the OMC, you will receive a confirmation email of your registration that includes an invoice in PDF format (within 24 hours). If the payment has not been received before the start of the conference, delegates will be asked to provide payment on-site via credit card. RECS reserves the right to refuse entry. Before travelling to the conference, we recommend you check with your finance department to ensure that payment has been settled.

## Cancellation Policy

Cancellations made within 48 hours (about 2 days) of receipt of registration will be eligible for a full refund. Cancellations received in writing more than two weeks prior to the start of the event will be refunded minus a

50% cancellation fee. Cancellations received in writing less than two weeks before the starting date of the event will not receive a refund, and you will be liable for 100% of the invoiced amount. However, a substitute delegate can be named at any time before the event starts, or a conference voucher (with the same value; valid for one year) will be offered.

If the event cannot be held due to circumstances created by a global pandemic, the event will be postponed. Tickets paid for in full will remain valid on the new conference date.

### Important Notes

The OMC ticket registration/booking form constitutes a legally binding contract. It may be necessary for reasons beyond the control of the RECS to change the content and timing of the program, the speakers, the date, or the venue for the conference. RECS retains the right to cancel the event without providing restitution.

Please also be advised that filming/photography may occur during the OMC. When you attend this event, you may enter an area where photography, audio, and video recording may occur. By registering for the event, you consent to such recording media and its release, publication, exhibition, or reproduction.
