



Terms and Conditions for RECS National GO Days

The RECS National GO Days are hosted by the **RECS Energy Certificate Association (RECS)**, sometimes in collaboration with partners such as the **Association of Issuing Bodies (AIB)** or local stakeholders. These events may take place in various countries, with specific dates and venues announced for each edition.

After the main event program concludes, registered delegates are typically invited to attend post-event networking activities such as drinks or dinner. The exact timing and location of these social events will be communicated closer to the date. RECS reserves the right to modify or cancel these elements if necessary.

Registration

The standard registration fees are as follows:

- **kr1750 (excl. VAT)** for RECS members – **kr2,187.50 with VAT of 25%**
- **kr3500 (excl. VAT)** for non-members – **kr4,375.00 with VAT of 25%**

The late registration fees are as follows:

- **kr3000 (excl. VAT)** for RECS members – **kr3,750.00 with VAT of 25%**
- **kr5000 (excl. VAT)** for non-members – **kr6,250.00 with VAT of 25%**

The registration fee generally includes:

- Access to all event sessions
- An online copy of the meeting program
- Post-event access to meeting papers
- Refreshments and lunch during the event
- Attendance at post-event drinks and dinner



Note that program inclusions may vary slightly depending on the host country and local circumstances. Full details will be provided for each event on its dedicated registration page.

Payment

Payments must be made via **credit card** at the time of registration. Upon registering, you will receive a confirmation email and an invoice in PDF format (within 24 hours). If payment has not been completed before the event, you may be asked to provide payment onsite via credit card. RECS reserves the right to deny entry if payment has not been received.

To avoid complications, we recommend confirming payment status with your finance department prior to attending.

Cancellation Policy

- **Full refund:** For cancellations made within **48 hours** of registration.
- **50% refund:** For cancellations received **in writing more than two weeks** prior to the event start date.
- **No refund:** For cancellations received **less than two weeks** before the event.

However, you may name a **substitute delegate** at any time before the event. Alternatively, a **conference voucher** equal in value (valid for one year) may be issued upon request.

In the case of postponement due to unforeseen circumstances such as a global pandemic, paid tickets will remain valid for the rescheduled event.



Important Notes

By submitting the registration form, you enter into a legally binding agreement. RECS reserves the right to change the program, speakers, schedule, or venue due to factors beyond its control. RECS also retains the right to cancel the event entirely without liability.

Photography, video, and audio recording may occur during the event. By registering, you consent to the use of your image and likeness in media associated with the event, which may be used for promotional or archival purposes.

Privacy Statement

RECS values your privacy. By registering for a RECS National GO Day, you agree to receive periodic event-related communications. Your **name, job title, and company** may be included in a delegate list shared at the event or with event partners and sponsors.
